In this Release Agreement, the term "Adventure Activities" shall include all activities, events, filming, photography, accommodation, transportation, and related services provided, arranged, organized, conducted, sponsored or authorized by the Releasees and shall include but is not limited to: skiing; snowboarding; snowmobiling; hiking; snowshoeing; tours; sightseeing and flightseeing; travel in the backcountry and mountainous terrain including avalanche terrain; travel on and in glaciers, ice caves, quinzhees, igloos; to, from and in hot spring; rock climbing, rappelling and abseiling; use of rental or loaned equipment; demonstrations; orientational and instructional courses, seminars and sessions; operating, loading, unloading and travel by or movement in or around helicopters, snowcats, snowmobiles, all terrain vehicles and motor vehicles; and other activities, events and services in any way connected with or related to Adventure Activities.

ACKNOWLEDGMENT - SAFETY

- I acknowledge that I am required to wear an approved helmet while participating in certain Adventure Activities.
- I acknowledge that I should seek medical advice if I know or suspect that my physical condition may be incompatible with Adventure Activities.

ASSUMPTION OF RISKS - AVALANCHES, ALPINE TERRAIN, TRAVEL, WEATHER ETC.

I am aware that participating in Adventure Activities involves risks, dangers and hazards. Avalanches occur frequently in the terrain used for Adventure Activities and may be caused by natural forces or by persons travelling through the terrain. I acknowledge and accept that the Releasees may fail to predict whether the alpine terrain is safe for Adventure Activities or whether an avalanche may occur. The terrain used for Adventure Activities is uncontrolled, unmarked, not inspected and involves many risks, dangers and hazards in addition to that of avalanche. The additional risk, dangers and hazards participating in Adventure Activities include, but are not limited to: travel by helicopter over mountainous or alpine environment; helicopter crashes; being struck by rotating helicopter blades and tail rotors; mechanical malfunction of helicopters; pilot error; changing weather conditions; cornices; crevasses; cliffs; trees, tree wells and tree stumps; rocks; boulders; forest deadfall; holes and depressions on or below the snow surface; variable and difficult snow conditions and limited visibility; variation or steepness in terrain; difficulty or inability to control one's speed, direction, stopping distances and turning radius; snowcat roads and road banks, fences, and other man-made structures; snow immersion; streams, creeks, lakes, rivers and glaciers; rolling or flipping the vehicles; effects of high altitude including pulmonary edema and cerebral edema; hypothermia and hyperthermia; impact or collision with structures, vehicles or objects; collision with other persons; loss of balance or control; slips, trips and falls; encounters with domestic or wild animals; becoming lost or separated from one's party, instructor or guide; equipment failure; failure to act safely or within one's own ability or stay within designated areas; negligent first aid; negligence of other persons, including other guests; and NEGLIGENCE ON THE PART OF THE RELEASEES.

NOTICE TO SNOWBOARDERS AND TELEMARK SKIERS - INCREASED RISK

Unlike alpine ski boot/binding systems, snowboard and some telemark boot/binding systems are not designed or intended to release and will not release under normal circumstances, thus increasing the risk of not surviving an avalanche.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of **THE RELEASEES** allowing me to participate in Adventure Activities, and permitting my use of their property, vehicles, trails, terrain parks, equipment and other facilities I hereby agree as follows:
